## Short-Haul Exception

A driver is exempt from the requirements of §395.8 and §395.11 if: the driver operates within a 150 air-mile radius of the normal work reporting location, and the driver does not exceed a maximum duty period of 14 hours. Drivers using the short-haul exception in §395.1(e)(1) must report and return to the normal work reporting location within 14 consecutive hours, and stay within a 150 air-mile radius of the work reporting location.

- The driver must not exceed a 14-hour workday, with a maximum of 11 hours of driving time. The driver must be off duty for at least 10 hours before starting a new duty day.
- The driver must keep accurate records of duty status (RODS) to document compliance with the short-haul exemption.
- The driver must not engage in the transportation of hazardous materials requiring placards.
- The driver is not required to take a mandatory 30-minute break after 8 hours of driving
